

## 1 – THE BOOK OF DANIEL: INTRODUCTION

### I. Why Study Daniel?

- There is confusion among God's people as we find ourselves in these times.
- There is an ignorance concerning what the Bible actually says.
- There is a tendency to know the interpretations of others rather than scripture itself.
- It is our desire that you become informed of what the scriptures say.

Scripture: Daniel 12:9-10

<sup>9</sup> And he said, "Go *your way*, Daniel, for the words *are* closed up and sealed till the time of the end.

<sup>10</sup> Many shall be purified, made white, and refined, but the wicked shall do wickedly; and none of the wicked shall understand, but the wise shall understand.

### II. A Realistic Approach

#### A. A diversity of views

- We need to recognize that good Christians have different views.

#### B. Flexibility in interpretation

- Don't be dogmatic about your interpretations.
- Recognize that the church has struggled to understand this book for centuries.

#### C. Understand the Purpose

- The purpose of the book is to provide hope in the midst of trials.

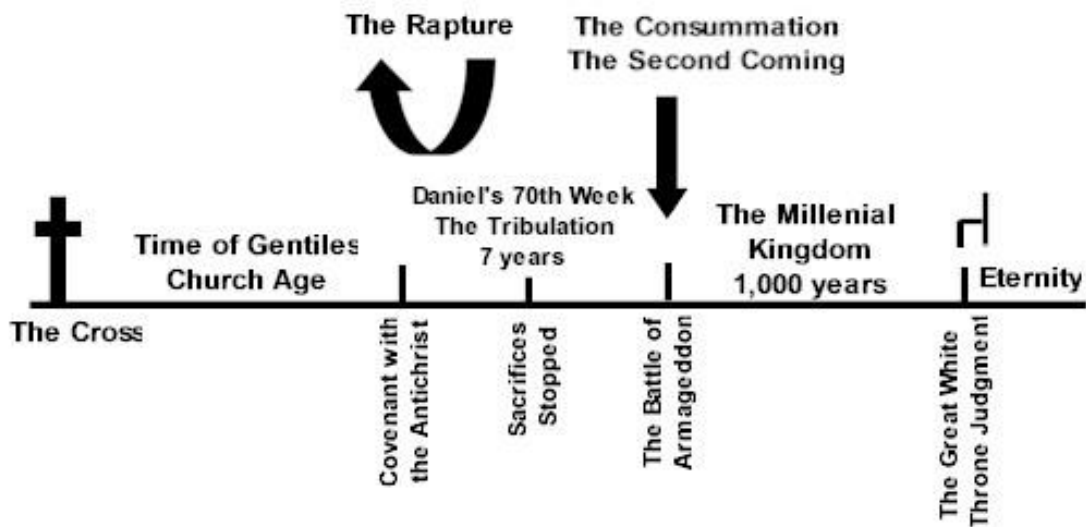
### III. Our Approach to the Study

### IV. The Author and Occasion

- Daniel was a Jew who was carried off in the first Babylonian conquest in 605 B.C.
- The book covers material until the third year of Cyrus in 536 B.C.
- The book was written in two languages: Hebrew and Aramaic.
- Chapters 1 & 8 to 12 are written in Hebrew and Chapters 2 to 7 in Aramaic.
- If he were 16 when captured, he was 85 in Cyrus' third year.
- Daniel may have lived until 530 B.C.
- Little is known of Daniel's family background.
- Daniel was born into the royal family and was of noble birth (Dan. 1:3,6).
- He was physically attractive and mentally sharp (Daniel 1:4).
- From the testimony of Ezekiel, he was known for his righteousness (Ezek. 14:14,20) and his wisdom (Ezek. 28:3).
- The book was probably completed in the last 10 years of his life.
- The prophet Daniel is mentioned by Jesus (Matthew 24:15, Mark 13:14).

### V. The Purpose of the Book

- The book is the record of the life and prophetic revelations given to Daniel.

- The book was written during the dark hour of the Babylonian captivity.
- There was a need for a new testimony concerning the mighty and providential power of God.
- It is not the purpose of the book to give a detailed account of Daniel's life.
- It is a revelation of God's program which culminates in the second coming of Jesus.
- The book emphasizes God's sovereign authority over Gentile nations.
- The book was also written to outline graphically the prophetic period known as "the times of the Gentiles" (Luke 21:24).
- The Book of Daniel marks the course of Gentile history through that extended period in which Israel was and is being disciplined by Gentiles.
- The Book reveals Israel's future deliverance and the blessings she will enjoy in the coming Millennial Age.
